



Florida Absentee Voting



Who can vote absentee

All registered voters are permitted to vote absentee under Florida law. You do not need to give any reason to ask for an absentee ballot.

Ways to vote absentee

You can vote by mail or in person before the primary and general election. Following are the instructions for both. Absentee ballot voting is managed by your local supervisor of elections. We have provided their contact information at the end of this document.

Vote by mail

To vote by mail you must request an absentee ballot from your local supervisor of elections. A voter may apply for an absentee ballot at any time during the election year, but in order for the ballot to be mailed to you, the Supervisor of Elections must receive your request no later than four days before the election.

Primary Election (September 5, 2006)

Your absentee ballot request must be received by August 30, 2006. We recommend that you apply for your primary absentee ballot by August 20, 2006 to allow enough time to process your application.

General Election (November 7, 2006)

Your absentee ballot request must be received by November 1, 2006. We recommend that you apply for your ballot by October 20, 2006 or earlier to allow enough time to process your application.

A voter may request an absentee ballot from the supervisor of elections in person, by mail or by telephone. One request can cover all elections within a calendar year. A copy of the application form follows these instructions. The voter requesting an absentee ballot must disclose:

- Their name;
- The address at which they are registered; and
- Their date of birth.

Early voting In person

Voting takes place at the office of the county supervisor of elections but you can call to see if additional satellite locations are available. We have supplied the phone number of your supervisor on a list that follows these instructions.

Primary Election

Early voting begins August 21 and ends on September 3, 2006.

General Election

Early voting begins October 23 and ends on November 5, 2006.

The voter is solely responsible for complying with any and all election laws and voting requirements.
