

**MISSISSIPPI**

- How do I request an absentee ballot?** ► By mail, write to your county's circuit clerk, asking for an application for an absentee ballot.
- Where do I send the request?** ► Find the election commissioners in your county at:  
<http://www.sos.state.ms.us/elections/elections.asp>
- What is the deadline for requesting an absentee ballot?** ► The Secretary of State's voter information guide recommends that you contact your Circuit or Municipal Clerk at least two weeks before Election Day.
- What is the voting procedure?** ► Mail in a request for an application for an absentee ballot. The counties take requests starting 45 days prior to Election Day. Once they send an application, fill it out and return it. They will mail you an absentee ballot, which must be filled out and returned to the county clerk's office.
- What are the deadlines for voting absentee?** ► Ballot must be received by the clerk by 5:00 pm the Monday before Election Day:  
May 29 for the Primary Election  
October 30 for the General Election
- What are the election dates and deadlines for 2006?** ► Primary Election: June 6  
General Election: November 7
